### **Who is allowed to set up a bank in Switzerland nowadays?**

Anyone who meets the statutory conditions and who obtains authorisation from the Federal Banking Commission may open a bank in Switzerland. The conditions for authorisation, which are laid down in the Banking Laws, are strict, as savers and investors need to be protected. For example, a bank must show that it has a sound organisational structure and the required minimum capital. Also, those entrusted with its administration and management must "enjoy a good reputation and thereby assure the proper conduct of business operations."
